About this Directory

On a bi-annual basis, PBI surveys Chicago's law firms regarding the pro bono projects in which their summer associates have participated. The information is then reported in the PBI Directory of Summer Associate Pro Bono Opportunities at Chicago Law Firms. In our 2006 survey, PBI asked approximately forty Chicago-area law firms to: (1) list the agencies and pro bono projects in which summer associates participate; and (2) list any special pro bono programs geared toward summer associates. Thirty one law firms responded to our survey. Their responses are listed on the pages that follow.

1. Agencies and Pro Bono Projects in which Summer Associates Participate

Our pro bono offerings will vary from year to year based on the firm's initiatives and the interests of the particular summer associate class. In 2006, our summer associates:

- Interviewed criminal defendants and other related parties regarding the indigent defense system in the State of Michigan. Currently, Dykema, along with the National ACLU, ACLU Michigan, Brennan Center for Justice and another partner law firm is calling for vast changes to Michigan's court system to protect the rights of the accused who can't afford legal counsel.
- Drafted a brief for and observed oral argument before the Seventh Circuit on an international kidnapping case referred by the National Center for Missing and Exploited Children.
- Participated in training and prepared self petitions to be filed with the U.S. Immigration and Citizenship and Immigration Services (formerly known as the "INS") pursuant to the Violence Against Women Act of 1994 (VAWA). VAWA self petitions are filed on behalf of battered women married to batterers who are United States Citizens or Legal Permanent Residents. A VAWA self petition is necessary when the batterer refuses or fails to properly document the victim's status in the United States. If approved, a VAWA self petitioner will be afforded legal status in the United States.

Our summer associates may also participate in other on-going pro bono projects, which can range from representing an individual in a eviction matter to participating in complex systemic and landmark pro bono litigation.

2. Special Programs for Summer Associates

Our pro bono projects for summer associates will vary from year to year. Over the last two years, summer associates have prepared a research memorandum and created a power point presentation on various areas of the law of interest to various legal aid agencies or non profits. The topics have ranged from "Federal and State Financial Resources Available to Third Party Caregivers of Minor Children" to "Kids and the Internet: What Nonprofits Need to Know about Using the Internet".

This work product is then given to a legal aid agency which then enlists the support of a pro bono attorney who will present a seminar based on the research memorandum and power point to the community in general. This project has been well received by participating agencies.

1. Agencies and Pro Bono Projects in which Summer Associates participate:

Jones Day Chicago lawyers handle a variety of pro bono matters, including asylum proceedings; habeas corpus petitions; school expulsion hearings; statutory summary suspension proceedings; civil, administrative and criminal appeals; employment counseling; leasing transactions; outreach to students in area public schools; incorporation of not-for-profit corporations and counseling for charitable corporations. A substantial percentage of the pro bono hours contributed by Jones Day Chicago lawyers is devoted to assisting refugees, referred to us by the National Immigrant Justice Center (NIJC), who have been persecuted in their home countries because of their race, religion, political opinion, ethnic background or membership in a particular social group to obtain asylum. In the last year, Jones Day attorneys have obtained asylum for five such refugees and have briefed and/or argued Seventh and Fifth Circuit appeals for six more. Also with the assistance of NIJC, Jones Day lawyers have filed petitions for clients seeking relief under the Violence Against Women Act and have assisted minors in seeking Special Juvenile Immigrant Visas.

Jones Day lawyers also assist in criminal appeals and habeas proceedings. Currently, such proceedings are pending in the Sixth, Seventh and Ninth Circuit Courts of Appeals. Through Northwestern University School of Law's Children and Family Justice Center, other Jones Day lawyers have represented Chicago Public School students in expulsion proceedings. In non or pre-litigation matters, Jones Day lawyers have provided counseling to the Anti-Defamation League, Kohl Children's Museum, Lambs Farm, the Spanish Coalition for Housing, the statewide Housing Action Coalition, the LAM Foundation, the Shedd Aquarium and Family Focus, Inc. Lawyers in the Chicago office have provided transactional pro bono legal services to many not-for-profit clients and clients who otherwise could not afford legal services, referred by the Community Economic Development Law Project (CEDLP), among other sources.

First, summer associates will comprise the bulk of the Latham & Watkins delegation heading to local detention facilities to report to the ABA on the conditions there. Their participation and interaction with facility personnel and detainees will be critical to the success of this important firm-wide project. Their work will culminate in the preparation of a report of their findings to the ABA which we hope and expect will go a long way towards improving the treatment of detainees in the Chicagoland area and the rest of the nation.
